

SET notifies 15 listed companies to urgently rectify their free float qualification in order to meet requirement within a specified period

The Stock Exchange of Thailand (SET) has posted CF signs on the securities of 15 listed companies which do not meet free float requirement since June 5, 2024 as follows.
